

TCEA APPLICATION FORM

ELIGIBILITY REQUIREMENTS

A student is eligible to apply for the TCEA at the end point of senior secondary schooling (Year 12 or 13) when they meet at least one of the following eligibility criteria:

1. where personal circumstances and/or family circumstances and/or trauma related experiences have had a significant impact on learning or caused difficulties in learning.
2. where an impairment, disability and/or condition impacts upon one or more aspects of their learning.

SUPPORTING EVIDENCE

The supporting evidence provided may be a Learning Plan (IEP) or school statement (*completed on this form*).

For Eligibility Requirement one (1) an IEP and a school statement are required. For Eligibility Requirement two (2) a school statement is required.
