## 2024 QUALITY ASSURANCE REGIONAL WORKSHOPS



In 2024 Quality Assurance Regional Workshops were held in Hobart, Launceston, and Devonport. Participants were invited to give feedback on their experiences by indicating their degree of agreement (or disagreement) with the following statements. The return rate was 100%.
