## SCHOOL SUPPORT

---

### Using Generative AI

During 2025, providers requested more guidance in how generative AI technologies (AI) should be used in courses. While teachers are best placed to guide their students about AI, TASC want to remind teachers – particularly those with a folio or inquiry as part of their course – of some key components to talk about with their students:

- Be open about the fact that AI is evolving quickly and no one has all the answers, including teachers.
- Be clear with your students about how you use AI yourself and model how AI can be used ethically as part of your explicit teacher instruction time in your classroom.
- Clearly outline how AI should and should not be used in your course.
- If AI is allowed in specific cases in your course, clearly outline how AI should be acknowledged and/or referenced and the referencing style that is appropriate for your course.
- Explicitly show your students how to regularly save their draft versions of the development phases as they construct their folio, especially regarding 'version history' trails.
- Have clearly documented dates (at least 3) for student drafts to be submitted to you during the folio period development phase and ensure drafts are uploaded through either your school's Learning Management System (LMS, e.g.: Canvas) or you have an electronic record of them to save centrally.
- Consider how you could get student feedback on how they are using AI in their folio/inquiry.

TASC is the independent education regulator in Tasmania, and one of our key roles is to support schools deliver high quality education outcomes for students.

TASC are keen to be proactive about continuing to improve. To assist in this, we encourage schools and TLOs to provide constructive feedback through the various avenues available. This can be done via:

### School Preliminary Results Report – Reminder

Your school's Preliminary Attainment Data Report (sent to schools in December) is available in TRACS and is accessible by those TRACS users that are assigned the role of Principal, Principal's Delegate or TLO.

The report is an Excel spreadsheet format. For help accessing your school's report, use the step-by-step TRACS Help guide at [How to access your students' results](#).

The information available in this report includes:

- TCE and ATAR Summary (including the TCEA)
- TASC Course Results
- Nationally or Interstate Assessed Languages (NIAL) Results (formerly CCAFL Results)
- TASC Recognised Results
- VET Unit Results
- VET Qualifications.

Please note this data is preliminary data based on students' results as of 16 December 2025. An updated copy of the report will also be shared with schools at the end of March. The final attainment figures will be verified with schools and be available in the second half of 2026.

## Paper-based TCE Everyday Adult Standards Tests

Schools continue to be able to access paper-based tests for the [TCE Everyday Adult Standards – Reading, Writing and Communication \(in English\)](#) and *Mathematics* in 2026, though it is preferable to register for online testing opportunities.

 **Reminder:** Year 11 students **cannot undertake** paper-based tests before Term 4.

## 2026 School and Student Enrolment Data

TRACS will be populated with 2026 enrolments following the system rollover on **Wednesday 1 April**.

**Catholic and Independent Schools:** Student and class data templates are being distributed via TRACS this week and will be available by Friday 6 February. **DECYP Schools:** Manage student and enrolment data in EduPoint.

Completed enrolment spreadsheets are due back to TASC by **Friday 6 March**.

## 2026 Online TCE Everyday Adult Standards Testing Windows

The first 2026 online testing windows for the TCE Everyday Adult Standards – *Reading, Writing and Communication (in English)* and *Mathematics tests* are provided below. We encourage TLOs to include these dates in their calendars now and work with their school to ensure registrations are done by the due date.

### Term 1 testing window

- 25 – 26 February (Writing test)
- 25 February – 13 March\* (Numeracy and Reading tests).

 **\*Note:** Testing will not be available Monday 2 and 9 March (due to public holidays in WA and Tasmania).

Registrations close **Thursday 12 February**.

**A reminder that the Term 1 testing window is only available for Year 12 students and former students. Year 11 students cannot sit this round of tests and will need to wait until the second half of the year to register.**

Please note, TASC are currently reviewing how Everyday Adult Standards tests are delivered to schools and this may result in changes to test availability and how tests are administered. Future test dates and

windows for 2026 will be communicated in upcoming *TASC Updates*. Updates on this review will be provided to schools in due course.

A reminder to schools that students who are looking to demonstrate the *Reading, Writing and Communication (in English)* Standard must sit **both** the Reading and Writing tests in the same window to be eligible to receive recognition of the Standard. It is at the school's discretion to schedule when students sit each test component of this Standard, meaning students can sit these on different days, but noting that the writing component is only available for a shorter period of time.

The online *Use of Computers and the Internet (ICT)* Everyday Adult Standard safety net test is available for registration to complete on demand at any time it is required (with a 3-month waiting period between tests).

#### Change of process for due dates to teachers:

From 2026, TASC is no longer publishing a “due date to teacher” for externally assessed folios. Only a due date to TASC will be published. Schools are responsible for setting and managing their own internal due dates to teachers to allow sufficient time for review, verification, and submission to TASC.



**Important:** Please note that practical external assessments may be scheduled on any date within the relevant range listed in the above schedule and these dates are not negotiable.

## Applications for Nationally or Interstate Assessed Language (NIAL) Courses

Applications to enrol in a [Nationally or Interstate Assessed Language \(NIAL\) course](#) close **on Friday 20 March**.

These courses are designed for learners who are background speakers of a language or who have extensively studied the language as a second language (learners must have at least 200 hours of instruction in the language). These courses are not taught in the school, so individual students will need to conduct their own preparation with the assistance of their school.

Schools who have student who wish to study for one of these exams need to complete an application through TRACS on the student's behalf, using the 'Nationally & Interstate Assessed Languages (NIAL) Administration' task type. ## Student Requests to Inspect Written Exam Material

Round 1 inspections of 2025 written exam materials are complete, and students have been advised of the outcome via email.

**Applications for Round 2 inspections of written exam materials** have closed. Unlike first-round inspections, second-round inspections are held at schools.

TASC will send schools information about the process and the materials they will require to host inspections **by Friday 6 February**. Schools will need to return completed second-round inspection materials to TASC **by COB Friday 20 February**.

## 2025 Student Results Queries
